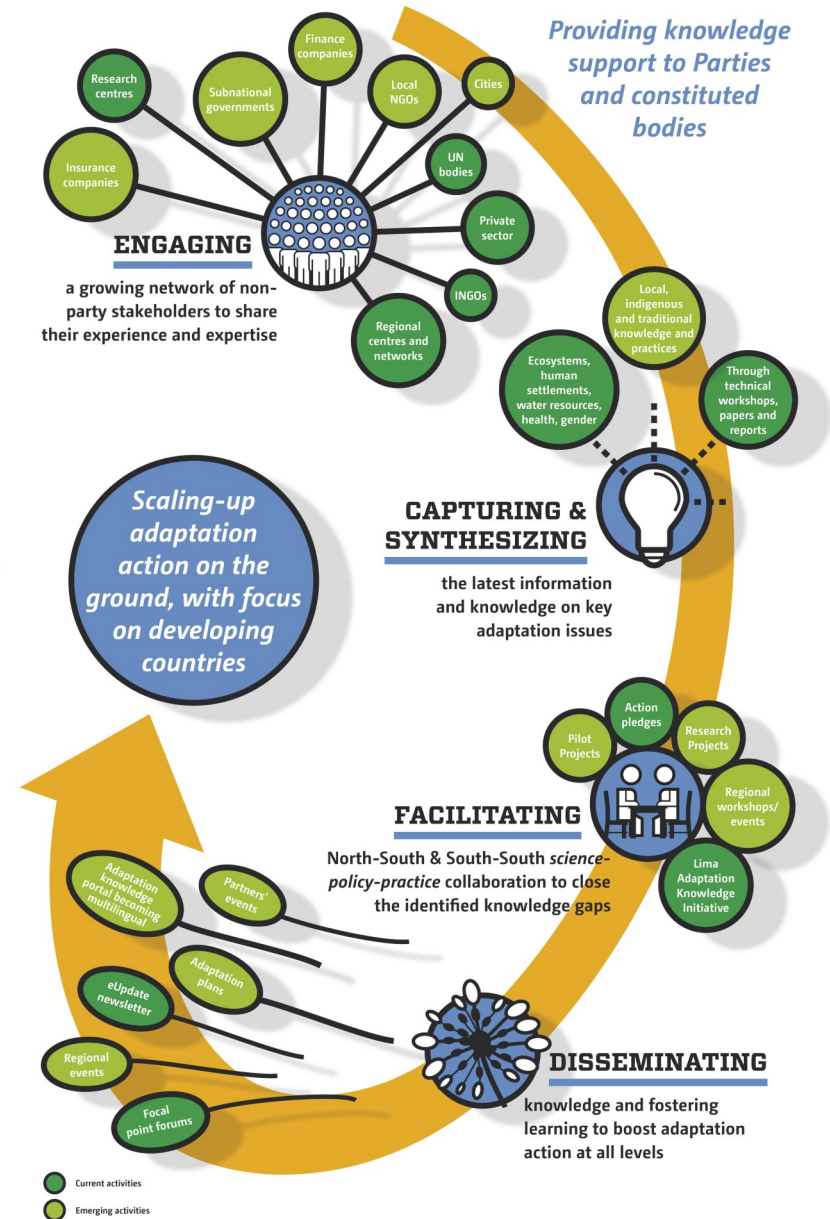

## What are the Nairobi work programme's focus areas on human settlements and adaptation?

During the 44th session of the Subsidiary Body For Scientific and Technological Advice ( SBSTA) in May 2016, Parties agreed there is a need for information including good practices, lessons learned and available tools and methods, in relation to:

- Assessing sensitivity and vulnerability to climate change;
- Integrating short- and long-term climate considerations; (including both extreme and slow onset events) into planning;
- The role of national governments in supporting local adaptation;
- City-to-city partnerships on climate change;
- Linkages to the National Adaptation Plan process;

Bearing in mind the unique challenges and scale differences in urban, rural and remote settlements, in particular in small island developing States and least developed countries.

Knowledge barriers are currently impeding adaptation planning and action at the regional, national and subnational levels. Governments (at all levels) and relevant organizations are invited to help bridge the gap from knowledge to action.

## How can you help bridge the knowledge-to-action gap?

- 🏠 **Share your experience** on adaptation planning and action addressing human settlements **by responding to the call for submissions** on the focus areas mentioned above **before 20 September 2017**.

- 🏠 The synthesis report will be considered during the **Climate Change Conference in May 2018**, and will inform the next steps in terms of bridging the knowledge-to-action gap on adaptation in human settlements.
- 🏠 As a follow up, your **contribution through ideas and collaborative actions** will be critical in bridging the knowledge-to-action gap.
- 🏠 The expertise of your organization will be internationally recognized or strengthened, including in the UNFCCC process, increasing your **leadership in scaling up adaptation action**.
