

# STATEMENT BY INDONESIA AT THE JOINT CLOSING PLENARY OF COP24, CMP14, CMA1

## Katowice, 15 December 2018

### Mr. President

We have seen that Parties are struggling over how to achieve consensus on the Paris Agreement rulebook for the last three years. My delegation recalled at the beginning of the Katowice session, Parties agreed to find a landing zone, call for putting aside the known differences and focusing on common goals in combating climate change, to agree on a complete-balance-and-coherence package to implement the Paris Agreement, which is applicable to all, with the principle of CBDR-RC.

My delegation would like to take this opportunity to express our gratitude to your leadership in guiding us to finally adopt the Katowice outcomes. We appreciate all Parties for the commitment to our collective goal under the Paris Agreement.

## Mr. President,

As an archipelagic country with almost 260 million population, Indonesia is very vulnerable to the impact of climate change, at the same time has a high mitigation potential especially in forest and energy sectors. We come here with a good faith to negotiate the Paris Agreement rule book, not only for protecting national interest but also protecting the global common for future generations. But, climate change is a global challenge, it can not be resolved by individual country, we need to act together, within the principles of CBDR-RC, equity, and flexibility.

#### Mr. President,

Implementation of the Paris Agreement rule book requires a fundamental change in many developing countries, including Indonesia. Provision of means of implementation as mandated by the Paris Agreement will enable developing countries meeting their commitment to the agreement, particularly in the transformation to long-term low GHGs emission and climate resilient, which must be balanced with economic growth and just opportunity for development.

On the Paris Agreement Work Programme, Mr. President, my delegation would like to highlight some issues regarding the Katowice Package:

- 1. On Finance, assessing progress in provision and mobilization of support is crucial. Such mobilization of climate finance should represent a progression beyond existing efforts.
- 2. On NDC, we welcome its timing of application of the further guidance for NDC, ICTU and accounting as well as the accompanied required supports.
- 3. We welcome decision on adaptation communication and further works as the follow up of AC Report. Support to developing countries in preparing and submitting adaptation communication is needed. Adequate support is also necessary to implement adaptation plan and action to improve resilience.
- 4. On transparency framework, we welcome flexibility provision for developing country parties, yet allowing improvement overtime. Provision of means of implementation is crucial for the implementation of transparency framework
- 5. On compliance, Indonesia recognizes the importance in paying particular attention to the Parties' national capabilities and circumstances, including in the case of force majeure. This

is particularly important as climate change is putting more challenges to natural-disasters prone country in implementing its NDCs.

In closing, Mr. President, my delegation would like to covey our appreciation to the UNFCCC Secretariat for their dedication, to the government and people of Poland and Katowice for their hospitality.
