#### Japan's Submission on Article 6, paragraph 4, of the Paris Agreement

September 2022

#### Introduction

Japan welcomes the invitation from the SBSTA to submit Parties' further views on the elements referred to in paragraph 7 of decision 3/CMA.3. Japan present its views on the following issue.

# Process for implementation of the transition of the clean development mechanism (CDM) activities to A6.4 and of use of certified emission reductions (CERs) towards first NDC (paragraphs 7(b) and 7(c) of decision 3/CMA.3)

- 1. Processes for implementation of the transition of activities from the CDM to Article 6, paragraph 4, in accordance with chapter XI.A of the annex (Transition of clean development mechanism activities)
- It is important that the transition of existing CDM activities (Project Activities (PA) / Programme
  of Activities (PoA)) and CERs has clear procedures that does not impede the implementation of
  administrative work of relevant stakeholders.
- Although various forms of applications including small-scale PA/PoA transition and provisional
  measures are expected, we propose that the standard transition process be established first and
  after that, the Supervisory Body will elaborate expedited transition process as referred to
  paragraph 74 of Annex in decision 3/CMA.3.
- Based on the rules, modalities and procedures for the mechanism established by Article 6, paragraph 4, of the Paris Agreement (6.4RMP), and other relevant rules and guidelines, we would like to propose the following processes for transition of the CDM activities.

### 2. Processes for implementation of chapter XI.B of the annex (Use of certified emission reductions towards first or first updated nationally determined contributions)

- In order to clarify how CERs are utilized for NDCs after having transferred to the 6.4 mechanism registry, it is important for each Party to appropriately report the details in the Article 6 reporting.
- To this end, the transfer process should be highly transparent so that the information of transferred CERs can be shown, and it is also important to have necessary infrastructure (a maintained website with details of the CDM projects, etc.) so that such information is properly kept as a record.
- Based on the 6.4RMP, and other relevant rules and guidelines, we would like to propose the following CERs transfer processes.

<sup>\*</sup> In this submission, we only focus on **CERs** held in the CDM registry. With regard to CERs held in national registries, separate processes should be elaborated.

## Proposed processes for implementation of transfer of CERs held in the CDM registry to the 6.4 mechanism registry
