Warm greetings from Bangladesh.

I am writing as a member of **SHBO** (**Service for Human Being Organization**) and the current Research and Documentation Lead of Bangladesh Youth COP 2025, a national youth-led initiative engaging young people in the **UNFCCC** process. We highly appreciate this opportunity to contribute to shaping the next five-year vision for the **GCAA**. Our feedback draws from firsthand engagement with climate-affected communities, youth networks, and grassroots organizations across Bangladesh.

1. What should success look like for the GCAA in the next five years, and how can it be measured effectively?

Success should mean that the GCAA:

- •Bridges the gap between global goals and local impact;
- •Demonstrates measurable progress in reducing emissions and increasing climate resilience, especially in frontline communities;
- •Delivers climate finance and capacity-building directly to vulnerable and underrepresented groups;
- •Tracks progress using both quantitative metrics (e.g., GHG reductions, adaptation indicators) and qualitative inputs (e.g., community-led assessments).
- 2. How can the GCAA facilitate direct and impactful engagement between Parties and NPS to support implementation efforts at both national and sectoral levels?
- By creating institutional platforms for youth, civil society, and grassroots groups to engage with Party representatives;
- By supporting co-created solutions in adaptation, energy, and loss and damage;
- By encouraging Parties to report on how NPS contributions are included in national NDC and NAP updates;
- By promoting localized pilot initiatives that are scalable and inclusive.
- 3. How can the GCAA promote inclusive and equitable engagement, particularly from underrepresented groups and regions?

- Establish regional hubs for climate dialogue in least developed and climate-vulnerable countries;
- Facilitate local consultations in native languages with Indigenous peoples, coastal populations, and youth;
- Provide funding, visibility, and leadership training for young climate actors, especially girls and marginalized communities;
- Guarantee access for grassroots organizations in official COP processes and Marrakech Partnership platforms.
- 4. What improvements can be made to ensure better transparency, reporting, and follow-up of the GCAA?
- Strengthen the Global Climate Action Portal (NAZCA) by including stories and data from local initiatives;
- Make the Yearbook of Global Climate Action more participatory, incorporating NPS contributions directly;
- Introduce community reporting templates for transparency and accountability;
- Ensure climate finance tracking includes disaggregated data (e.g, how much reaches youth-led or women-led initiatives).

As a representative of both SHBO and Bangladesh Youth COP, I strongly believe that climate action must be co-owned by those at the frontline of the crisis. We hope that our feedback contributes to a more inclusive and impactful vision for the GCAA. We remain available for any follow-up or consultations.
