What should success look like for the GCAA in the next five years, and how can it be

Measured effectively?

1, Enhanced Engagement and Collaboration between Parties and Non-Party Stakeholders

Achieving more meaningful, structured, and sustained partnerships that lead to tangible climate actions.

Measurement: Number of joint initiatives, collaborations, or projects launched between governments and NPS, and their reported impacts.

2, Accelerated Global Climate Action Milestones

Clear milestones such as reductions in greenhouse gas emissions aligned with the Paris Agreement targets.

Measurement: Quantitative progress in emission reductions at national and sectoral levels, monitored through credible data sources.

3, Effective Use of Climate Action Tools and Platforms

Widespread, transparent, and consistent reporting via tools like the Global Climate Action Portal (NAZCA) and the Yearbook of Global Climate Action.

Measurement: Increased submissions, user engagement metrics, and improved data quality and accessibility.

4, Transformation in Sectoral Climate Solutions

Adoption and scaling of innovative climate solutions across key sectors (energy, transportation, agriculture, etc.).

Measurement: Number and scale of sector-specific initiatives, investments mobilized, and measurable impacts on emission reductions.

5, Strengthened Monitoring and Accountability Mechanisms

Establishment of robust, transparent systems for tracking progress and holding stakeholders accountable.

Measurement: Implementation of monitoring frameworks, frequency of reporting, and stakeholder feedback on transparency.

6, Recognition and Celebrating Success Stories

High visibility and acknowledgment of impactful actions, inspiring further commitments globally.

7, Measurement: Number of awards, recognitions, and media coverage highlighting successful initiatives.

Increased NDC and NAP Implementation Rates

Success would be reflected in a significant rise in the number and quality of countries effectively implementing their Nationally Determined Contributions (NDCs) and National Adaptation Plans (NAPs).

Measurement: Track the percentage of countries meeting or exceeding their climate commitments, using progress reports and independent assessments.

Implement Clear Guidelines and Incentives for NPS Participation

Develop transparent frameworks that define roles, responsibilities, and expected contributions of NPS. Offer recognition, funding opportunities, or technical support to incentivize meaningful engagement and ensure their efforts directly support NDC and NAP implementation.

Strengthen Partnership and Knowledge-Sharing Initiatives

A, Facilitate joint projects, pilot programs, and knowledge exchanges that allow Parties and NPS to work together on concrete initiatives. Use success stories and best practices to inspire replication and scale-up at national and sectoral levels.

B.Create Dedicated Multi-Stakeholder Platforms and Forums

Establish regular, accessible online and in-person platforms where Parties and NPS can collaborate, share experiences, and co-develop solutions. These forums should focus on specific sectors and national contexts to ensure relevance and actionable outcomes.

Underrepresented groups and regions?

Ensure Representation and Voice in Decision-Making Processes

Establish mechanisms such as advisory committees or stakeholder panels that prioritize diversity and inclusivity, ensuring that underrepresented groups have meaningful opportunities to influence policy and program development. This can involve quotas or dedicated seats for these groups in consultations and planning forums.

Develop and Promote Inclusive Communication and Engagement Tools

Use multilingual, accessible, and culturally sensitive communication channels to reach diverse audiences. Leverage local media, community networks, and digital platforms to facilitate participation from regions with limited connectivity or resources, ensuring that their perspectives are heard and integrated into the GCAA's work.

Develop tailored outreach initiatives and capacity-building activities specifically designed for marginalized communities, indigenous peoples, youth, women, and underrepresented regions. This includes providing training, resources, and platforms that empower these groups to participate actively in climate action discussions and decision-making.
