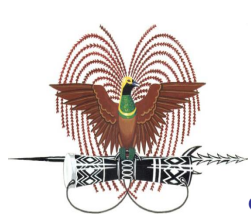

Guiding Principles and facilitative guidance for the construction, comparison against, and update of base years, baselines and reference levels, as appropriate – including for sectoral base years, baselines and reference levels used as a component of an NDC³ is consistent with the provisions provided under the PNG Climate Change Management Act 2015

Note : Most information required will be effected by virtue of regulations; starting with Forestry, Agriculture, Energy, International Transport (Aviation & Maritime) soon to be established, once all sectors mentioned above are declared by their Ministers to be regulated sectors. Transport, may proceed immediately hopefully this year, due to PNG's participation in the CORSIA; while APA progress is slow under the Mitigation Section on NDCs, PNG wishes to proceed without haste, as our deadline to provide a next NDC is 2020; and our intention is to transit immediately to an Economy Wide Reporting, in accordance with Article 4.4
